SPECIAL BOND ELECTION PROPOSITION Y

Shall the Board of Education of the Cape Girardeau School District No. 63 borrow money in the amount of \$12,000,000 for the purpose of acquiring, constructing, renovating, expanding, improving, furnishing and equipping school sites, buildings and related facilities for school purposes, including the renovation and expansion of Alma Schrader Elementary and Jefferson Elementary, and construction of an early childhood center, and construction of an aquatics center in partnership with the City of Cape Girardeau and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the school district is estimated to remain unchanged at \$0.68 per one hundred dollars assessed valuation of real and personal property.
